Republic Act (RA) No. 11642, also known as the Domestic Administrative Adoption and Alternative Child Care Act was signed and approved on January 6, 2022, and became effective on January 28, 2022. RA 11642 is an act strengthening alternative childcare by providing for an administrative process of domestic adoption and alternative childcare, reorganizing for the purpose of the Inter-country Adoption Board (ICAB) into the National Authority for Child Care (NACC), amending the purpose Republic Act No. 8043, Republic Act No. 11222, and Republic Act No. 10165, repealing Republic Act No. 8552, and Republic Act No. 9523, and Appropriating Funds, therefore.

The law provides for and allows simpler and inexpensive domestic administrative adoption proceedings and shall streamline services for alternative childcare. The NACC shall exercise all powers and functions relating to alternative childcare including declaring a child legally available for adoption and intercountry adoption, foster care, kinship care, family-like care, or residential care. All duties, functions, and responsibilities of the Inter-Country Adoption Board (ICAB), the DSWD, and those other government agencies relating to adoption and alternative childcare are transferred to the NACC.





To place Filipino children and individuals in need of adoption or alternative child care with suitable, secure, and nurturing families through streamlined administrative services ensuring their welfare and

best interests.

All Filipino children in need of adoption or alternative care belong in a safe, loving and supportive family and community where they can thrive to become productive citizens.

HIGHLIGHTS OF ACCOMPLISHMENTS

LAUNCHING OF OMNIBUS GUIDELINES OF RA 11642



Following the enactment of RA 11642 and its Implementing Rules and Regulations (IRR), the creation of the Omnibus Guidelines on Adoption and Alternative Child Care has facilitated the guidance of implementers and social workers in optimizing the adoption and alternative child care processes.

Presented to collaborating implementers, the newly formulated Omnibus Guidelines on Domestic Administrative Adoption and Alternative Child Care aim to outline the procedural framework for executing domestic administrative adoption proceedings. These procedures are specifically designed for implementation by the NACC, RACCOs, and their partnering implementers, in accordance with the provisions of R.A. No. 11642 and its Implementing Rules and Regulations.

The Domestic Adoption Division (DAD) within the National Authority for Child Care facilitates the review and assessment of documentation, providing recommendations for the issuance of various adoption-related certifications including Certification Declaring a Child Legally Available for Adoption (CDCLAA), Intercountry Adoption (ICA) clearance, and Order of Adoption and Finality. Additionally, in collaboration with Regional Alternative Child Care Offices, DAD monitors the progress of adoption cases concerning children identified for adoption in DSWD-Residential Care Facilities (RCFs) and NGO-Child Caring Agencies (CCAs) nationwide, offering technical assistance as needed.

Continuous efforts are made by NACC-DAD to streamline processes, achieved through the issuance of policies and guidelines and significant amendments to existing protocols, aimed at enhancing the implementation of adoption programs and services.

In the period spanning from January to December 2023, the number of cases served for CDCLAA issuance is 524 (96.15% of the total), with 391 cases processed for the issuance of Pre-Adoption Placement Authority (PAPA) on Regional and Interregional Matching conferences. Additionally, 158 cases received Orders of Adoption and 86 ICA clearances, resulting in a total of 867 cases served overall (277.29% of the target).





The Prospective Adoptive Parents (PAPs) accepted a total of fifty-six (56) children, while onehundred eighteen (118) children were entrusted to their PAPs. Among the 118 children, seventy (70) were Special Needs Children. The graph illustrates fluctuating trends for all types of adoption throughout the first semester, with regular adoption showing its highest peak in the 4th quarter and the lowest drop in the 2nd quarter.





Sixty-six (66) new adoption applications underwent assessment. Of these, thirty-five (35), or 53.03% were from the USA, fifteen (23), or 22.73% were from Europe, fourteen (15) or 21.21% were from Canada, and two (4), or 3.03% were from Asia Pacific. Twenty-five (25) of these applications were added to the roster of approved applicants.

Currently, NACC has two hundred thirty-eight (238) approved Prospective Adoptive Parents (PAPs) awaiting child referral. Among these, thirty-nine (39) are PAPs with Filipino heritage, while one hundred ninety-nine (199) PAPs are foreigners.

As per the latest update from the Roster of Approved Applications (RAA), six (6) prospective adoptive parents have sought temporary suspension of their applications. This request aims to accommodate the completion of the nurturing period requirement following the birth of their biological child.

Moreover, it has been noted that a total of sixty (60) applicants have opted to withdraw their applications. Reasons for withdrawal include the prolonged waiting period to receive a matching, attributed to the limited availability of children cleared for intercountry adoption, as well as various personal reasons cited by the applicants. Notably, the highest number of prospective adoptive parents withdrew their applications during the 2nd semester.

The goal for successful reunions between adult adoptees and their birth families is to achieve 100% of the actual number of adoptees who travel to the Philippines seeking reunion. In 2023, three (3) adoptees successfully reunited with their birth families.

Twenty-nine (29) adoptees participated in the Motherland Tour in the Philippines. They visited various tourist destinations to explore their roots and immerse themselves in the local culture. During the tour, they reconnected with their child-caring agencies and visited the NACC office.

Additionally, thirteen (13) successful searches were concluded within the year, with the highest number of successful searches occurring in the first quarter (8 cases).

The majority of these inquiries, amounting to three hundred seventy-six (376), were received via email. 17TH PHILIPPINE GLOBAL CONSULTATION ON CHILD WELFARE SERVICES



The Philippine Global Consultation on Child Welfare Services (Global Consultation) is a commitment of NACC to its local and international partners. It is a venue where local and international adoption specialists meet and discuss issues and concerns affecting the adoption of Filipino children. The Global Consultation is participated in by Foreign Central Authorities, Foreign Adoption Agencies, local Child Caring and Placing Agencies, Foreign Embassies/Consular Offices, Family Courts, and local government units.

Major activities during the consultation will be plenary sessions and open fora. The activities will provide the participants a venue to meet, draw lessons from shared experiences, formulate appropriate strategies, and enhance knowledge on issues relevant to inter-country adoption.

GENDER AND DEVELOPMENT

GAD - On July 24 to 28, 2023, a Seminar-Workshop on the Formulation of the NACC Gender & Development Agenda was held . The 5-day training workshop was based on the standard design of the Philippine Commission on Women and the personal inputs of the GAD resource persons. There was a review of the basic gender and development concepts focusing on what is sex and gender, what is gender mainstreaming in child care, gender and social inclusion, gender development, gender analysis, common tools in gender mainstreaming, and the 7 steps of the agency's 6-year Gender plan

PROGRAM REVIEW AND EVALUATION WORKSHOP




For 2023, the agency used McKinsey's 7S Framework to assess the overall implementation (commonly referred to as Program Review & Evaluation Workshop) of Adoption and Alternative Child Care. Under this model, there are hard (Strategy, Structure, and Systems) and soft elements (Style, Shared Values, Skills, and Staff). The seven (7) elements are the pillars of the agency and essential for its continued existence. The hard components are identifiable variables since these are found in policies or written documents and could be changed if needed, to achieve better results. While the soft components are intangible and sometimes less attention is given to these areas.

Income Earned from Fees and Charges as of December 2023




In the specified period, the NACC has accumulated a total income of Four million, eight hundred eighty-eight thousand, eight hundred eighty-seven pesos, and forty-six centavos (4,888,887.46) from fees and charges. This amount signifies a substantial segment of our overall revenue for the period under review.

Statement of Allotment, Obligation, & Balances as of December 30, 2023



As of the reporting date, the total obligation incurred stands at three hundred thirty million, three hundred sixty-five thousand, three hundred sixty-one pesos, and thirty-nine centavos (330,365,361.39). This figure reflects the cumulative financial commitments made during the specified period under review representing 85.63% of the fund utilization. This percentage indicates the extent to which the allocated funds have been utilized or committed.





STRENGTHS

- Policy Development: Following the enactment of RA 11642 and its Implementing Rules and Regulations (IRR), the NACC crafted the Omnibus Guidelines on Adoption and Alternative Child Care with the guidance of implementers and social workers to ensure an optimized process on adoption and alternative child care.
- Monitoring and Evaluation: Rigorously conducted Monitoring Visits and Technical Assistance (MVTA) to RACCOs, CCAs/CPAs, and various LGUs on the implementation of RA 11642.
- Developed monitoring tools for foster parents and foster children as guided by the Foster Care Social Workers for red flags in the child's placement in foster care.
- Expertise and Specialization: A pool of experts, which comprised the Child Placement Committee at the Regional, Interregional, and Intercountry levels facilitates the immediate deliberation of PAPs' application, matching of children, and issuance of necessary clearance of children for interregional or intercountry adoption.
- Creation of Technical Working Group on Alternative Child Care and its sub-committee on KAYA ko! (Kaalaman at Abilidad, Yamang Angkin ko!) to develop programs and services for aging-out foster children in preparation for independent living where they can thrive and become productive citizens.
- Coordination with Stakeholders: Rebrand the AKBB into the Philippine Foster Care Program (PFCP) expanding its implementation from a single barangay to the whole LGU (municipality/city or provincial) and removing the counterpart subsidy from LGU, which encouraged the interest and participation of several municipalities and cities to enter into a MOA with NACC.
- Collaboration with the Council for the Welfare of Children (CWC) for the inclusion of Adoption and Alternative Child Care in the Child-Friendly Local Governance Audit (CFLGA) in the subindicator and rating system under the Protection and Governance Indicator
- Advocacy and Awareness: Launched a campaign against illegal adoption online such as the selling of babies and the unborn via Facebook
- Increased number of placement of children under Special Home Finding or older children, sibling groups, and children with special needs through the developed advocacy and strategies
- Established public awareness of the fresh mandate of the NACC and the streamlined processes and systems of Administrative Adoption and Alternative Child care
- Successfully introduced NACC and RACCOs to traditional media as the country's central authority on alternative child care
- Public acceptance of the ongoing AMPON campaign to help foster a positive environment for adoption and curb its stigma
- Build strong partnerships with local and foreign stakeholders through the Global Consultation on Child Welfare Services



CHALLENGES

1. Inter-agency Partnership:

- The Philippine Statistics Office (PSA) has yet to issue guidelines on registering the Order of Adoption and issuing a new birth certificate for the child/adoptee under RA 11642.
- Some local civil registrars (LCRs) are not yet aware of the importance of registering foundling children/adults under RA 11767. The PSA has not yet issued guidelines on the registration of COLB of foundling children; hence, LCRs are not guided on how to register the COLB, which delays the processing of CDCLAA.
- Slow developments in inter-agency partnership with the NBI and the need to engage ICT to identify, track, and prosecute perpetrators.

2. Limited Access:

- There are challenges in securing documentary requirements, i.e., psychological evaluation of children and PAPs, pediatric developmental assessment, etc., due to the limited number of service providers/psychologists in the area and the cost of such evaluations.
- A limited number of Foreign Adoption Agencies that provide a program which enables the placement of children with special needs

3. Human Resource Allocation

• The number of approved plantilla positions does not complement the overall functions of the Divisions/Units.
